

# **Māori Land Court**

A GUIDE TO OUR MINUTE BOOK ABBREVIATIONS

This factsheet provides information about, and a summary of, abbreviations used for minute books of the Māori Land Court and Māori Appellate Court

## Introduction

In the 150 year history of the Māori Land Court evidence and decisions have been recorded in local (and more) recently national minute books.

This fact sheet provides a guide to minute book:

- naming conventions
- series types
- syntax
- hints and tips
- abbreviations.

# **Naming Conventions**

Historically each registry office of the court was responsible for the creation and maintenance of their minute book series.

Like other regional courts, judicial officers and their support staff travel to different locations across New Zealand to hear and determine applications.

In a pre-digital context, it simply wasn't practical to have one minute book series for a district or the court as a whole; rather, it made more sense to have multiple minute books based on geographic location or activity.

Prior to its integration into the Department for Courts and Ministry of Justice, the Māori Land Court was part of a section within the Department of Māori Affairs (often referred to as the court section). Disestablished in 1989, the former Department had support staff located at many offices around New Zealand who maintained minute book series for judicial officers and/or bodies working in their

respective areas or for specific departmental or land board activities.

As an example, in the Taitokerau District of the Māori Land Court, minute books were maintained for Auckland, the Bay of Islands, Kaikohe, Kaitaia and Whangārei as well as for the District Māori Land Board and for the Bay of Islands Consolidation scheme.

## **Series types**

Early minute book series dealt with land investigations for a regional location.

As the role of the Department (Native and Māori Affairs) evolved, the type of minute books also evolved to include a wider range of activities.

These activities differed depending on legislation in force at the time and varied depending on the registry.

In general the following types of minute books were kept:

- Geographic: Usually a hearing venue had its own minute book which dealt with all applications in the surrounding geographic area (ie. – Whangārei, Auckland, Hamilton and Rotorua minute books)
- Adoptions: Dealt specifically with adoptions between 1909 and 1962.
- Consolidation: Recorded title consolidations undertaken as part of a consolidation scheme initiated by the local Māori Land Boards. Minute books also recorded succession to interests that were subject to consolidation up until final allocation of new titles was made.

- Alienation: Some offices kept specific series relating to the lease and sale of Māori Land which required confirmation of the local District Māori Land Board
- Judicial: In some cases, early judicial officers would maintain their own minute book series for specific investigations or because they would be away from a regional centre for long periods of time
- Quasi-judicial: Where a Registrar or Deputy Registrar acted in a quasi-judicial power afforded them under legislation, these were recorded in a separate series
- Chief Judge: The Chief Judge of the Court has, since 1931, had the jurisdiction to amend or cancel any order of the court or of a registrar (back to 1865) where there is an error, omission or mistake in the facts. Evidence and decisions are recorded in a separate minute book series.
- Appellate Court: Established as the Native Appellate Court in 1894, the (now) Māori Appellate Court has its own minute book series.
- Other: There are examples where a minute book has been created for a specific activity, application, hearings or other reason which requires evidence to be recorded. These series vary from region to region.

# **Syntax**

In early 2000, as part of the rollout of a new electronic system, the court captured (as images) its existing minute book series in the Māori Land Information System (MLIS).

To enable this to occur, a standard on indexing was set, and between 2001 and 2002, the court captured the majority of its historical minutes which are now available to court staff and members of the public at any court office.

This standard syntax style is used by the Māori Land Court to locate its historical minute books.

Please note: This syntax differs from the Legal style guide for referencing a decision of the Māori Land Court or Māori Appellate Court.

When referencing a decision of the court, the full legal style guide should be used in addition to the syntax described in this guide.

#### STANDARD REFERENCE SYNTAX

The standard syntax for minute book series is as follows:

#### NN MB PP or NN MB A-Z

#### Where:

- NN = minute book number
- MB = abbreviation associated with the minute book
- PP = folio(s) or page(s)
- A-Z = used in place of the folio or page numbers to indicate a search for the index pages associated with the particular minute book.

#### For example:

- 51 Opotiki MB 67 translates to 51 OPO 67
- Opotiki 51/67 translates to 51 OPO 67
- 5 Northern Waiapu Consolidation Scheme 94-99 translates to 5 CNNWP 94-99
- 5 Rotorua Appellate Court MB 100 *translates* to 5 APRO 100

## **CHIEF JUDGE REFERENCE SYNTAX**

The syntax for the Chief Judge series differs depending on the date of the decision.

For decisions made between 1922 and 1964:

#### NN CJ PP or NN CJ A-Z

#### Where:

- NN = The minute book number (ranging from 1 to 10)
- CJ = The abbreviation for the Chief Judge minute book series
- PP = The folio(s) or page(s)

 A-Z = Is used in place of the folio or page numbers to indicate a search for the index pages associated with the particular minute book.

As an example: 5 Chief Judge's MB 390 *translates to* 5 CJ 390

For decisions made after 1965:

#### YYYY CJ PP or YYYY CJ A-Z

#### Where:

- YYYY = year of the book (ranging from 1965 to 1971)
- CJ = abbreviation for the Chief Judge minute book series
- PP = folio(s) or page(s)
- A-Z = used in place of the folio or page numbers to indicate a search for the index pages associated with the particular minute book.

## For example:

- 1967 Chief Judges MB 100 translates to 1967 CJ 100
- 1971 CJMB 100 translates to 1971 CJ 100
- 2010 Chief Judge's MB 99-100 translates to 2010 CJ 99-100
- CJMB 1981/203 translates to 1981 CJ 203

## **CHIEF JUDGE INTERAL REFERENCE SYNTAX**

Since 1965 the court administration also maintained an internal historical register of applications to the Chief Judge.

These manual registers, held in Wellington, list applications received between 1965 and 2001.

You may see applications referred to as:

## CJ YYYY/NN

#### Where:

- CJ = prefix to indicate the application is one made to the Chief Judge
- YYYY = year in which the application was received (starts from 1965-)

 NN = A sequential number which is incremented as a new application is received.

For example, in minutes of the court you may see CJ 1964/18

This internal reference is not currently available electronically and must be searched in manual registers held in Wellington.

In 2001, an electronic register was created but is only available to court staff in Wellington.

# REGIONAL CHIEF JUDGE MINUTE BOOK SERIES

Applications heard by the Chief Judge in a Māori Land Court District, or, an application which was referred for inquiry and hearing in a District are recorded in regional Chief Judge minute books.

For decisions made between 1894 and 2010:

#### NN MB PP or NN MB A-Z

#### Where:

- NN = minute book number
- MB = regional abbreviation for the local Appellate Court minute book series
- PP = folio(s) or page(s)
- A-Z = used in place of the folio or page numbers to indicate a search for the index pages associated with the particular minute book.

# APPELLATE COURT INTERNAL REFERENCE SYNTAX

Since 1921 the court administration also maintained an internal historical register of applications to the Native (now Māori) Appellate Court.

These manual registers, held in Wellington, list applications received between 1921 and 1989.

You may see applications referred to as:

## APPEAL YYYY/NN

### Where:

- APPEAL = A prefix to indicate the application is one made to the Appellate Court
- YYYY = The year in which the application was received (circa 1921-)
- NN = A sequential number which is incremented as a new application is received.

As an example, in minutes of the court you may see APPEAL 1964/18

This internal reference is not currently available electronically and must be searched in manual registers held in Wellington.

An electronic register is also available but it is only available to staff in Wellington.

## **Hints and Tips**

- Court staff can't search for a minute or judgment based on subject. You need to have an application number (post 1999) and/or a proper minute book reference
- Where possible always express your requests using the minute book syntax and its abbreviation. If you have your syntax correct, staff can simply enter the reference into the records system and retrieve the minute or judgment
- Try and establish a location for the hearing and the appropriate Māori Land Court District in which it was heard
- If your minute can't be found you may be able to locate the decision based on the date it was delivered. If you have an exact date or date range – you can ask for staff to search records for the given date or range
- Check the register of decisions on the Māori Land Court website in the judgments section (www.maorilandcourt.govt.nz/legislationdecisions/)
- You can find minute book references for different blocks or current ownership by searching our Māori Land Online website (www.maorilandonline.govt.nz)
- If you still can't find your minute you may need to contact the appropriate Māori Land Court District office and ask if the manual registers can be checked

- Note: This type of research could take up to 10 working days to check and the local office may no longer keep such records
- All Chief Judge enquiries should be directed to National Office in Wellington
- Appellate Court decisions prior to 2010 should be directed to the Māori Land Court office in which the application was heard
- All other Appellate Court enquiries should be directed to National Office in Wellington.

## **COPY FEES**

Please note: The Māori Land Court Fees Regulations 2013 set the following fees for copying records (regardless of whether or not it is supplied electronically or as a hard copy):

- 20c per black and white page
- 40c per colour page

There is limited discretion to reduce or waive this fee, however this is considered on a case by case basis and large requests, or those that require significant research, may incur a fee.

## **Abbreviations**

What follows are the abbreviations in use by the Māori Land Court which is listed by District Office.

When requesting minutes (or orders generated from those minutes) it is important to use the syntax adopted by the Court.

You can contact any office of the court to seek copies; however, if these are not available in the court's document management system, you will need to contact the office in which those records are located so they can review the physical file and where possible copy the physical record.

Please note that research requests may take up to 10 days to complete and court staff may not be able to locate the information or if your request requires significant research you may be asked to undertake that research yourself at office in which the records are located – physical files are only available for viewing in the office in which the are located.
