Applications for Determination by a Registrar Which are Considered Simple and Uncontested

If you are interested in, or affected by, one of these applications and wish to make submissions or provide evidence concerning the application, you must notify the Registrar in writing by 4 pm on the 1st May 2021, providing your name and address, telephone number, and email address (if any), and setting out your connection to the application and brief details of your concerns.

The Registrar may, on receiving your notification, arrange for the application to be set down for a formal hearing before a judge.

Where a determination or order has already been made by a Registrar, affected persons may also apply to the court to seek a review of that determination or order. A review must be lodged within 20 working days after the determination or order is made or, at the satisfaction of a Judge, within a longer period.

The changes are designed to remove barriers for landowners and support connection to and use of whenua.

Dispute resolution service

Effective from Waitangi Day, 6 February 2021

In August 2020, the Government passed targeted changes to Te Ture Whenua Māori Act 1993 to simplify the legal processes for owning, occupying and using Māori land.

What has changed?

Historically, disputes over Māori land often had to be resolved through public court sittings before a judge.

Now, landowners and other court users can choose to resolve disputes related to Māori land through a free tikanga-based dispute resolution service provided by the Māori Land Court. This service provides access to high-quality mediation to settle disputes in a culturally appropriate and confidential environment outside of a court.

The mediator will guide the parties in the dispute through mediation based on the tikanga agreed by the parties.

If an agreement is reached through mediation, the mediator will record the terms of the agreement and provide this to the Māori Land Court. The mediation conversations will not be part of the public court record.

If necessary, a judge may make a court order to formalise what has been agreed by the parties.

Why make this change?

Disputes about whenua Māori can be complex and difficult for whānau. They can delay whānau connection to whenua, and plans for developing land. Court processes can also be time consuming and costly.

By creating a free, culturally appropriate and safe process outside of a court sitting, landowners and other Court users can kōrero and wānanga about the dispute privately and come up with their own workable solutions.

Who mediates?

Initially Māori Land Court judges will act as mediators. In the future, the service will be supported by a pool of non-judicial mediators identified to have the right skills to support disputes over Māori land.

When a judge is appointed as mediator, they will not be able to sit on the court proceedings related to that specific case.

What do I need to do?

If you want to make an application to the Māori Land Court or you have an application already in the Māori Land Court that is being delayed by a dispute, you can apply to use the dispute resolution service to attempt to settle the dispute outside of a court sitting. A judge may also refer any issue arising in court proceedings to mediation.

The dispute resolution service is voluntary, so all the people involved in the dispute must agree to take part.

When an application for dispute resolution is accepted, you will need to be available to attend the dispute resolution (mediation) hui when scheduled.

You will be included in discussions to confirm a suitable date and venue for the mediation hui, and to agree on the tikanga during mediation.

The parties involved in the dispute will need to agree on the mediator to be used, or one can be appointed for you.

What if an agreement is not reached?

If the parties cannot come to an agreement, the mediator will notify the Māori Land Court. There will be options available when considering the next steps to resolve the dispute, including going to court or going back to mediation with the same or a different mediator.

What costs are involved with mediation?

The dispute resolution service is free of charge, but you may need to meet the costs of travel to attend mediation and of any independent legal advice (if you choose to seek it).

Simple and uncontested succession applications

Effective from Waitangi Day, 6 February 2021

In August 2020, the Government passed targeted changes to Te Ture Whenua Māori Act 1993 to simplify the legal processes for owning, occupying and using Māori land.

What has changed?

Succession is the legal transfer of interests or shares in Māori land from a person who has passed away to the people who are legally entitled to own those interests.

Historically, most succession applications were heard by a Māori Land Court judge.

Now, if your succession application is assessed to be 'simple and uncontested', then it can be decided by a Māori Land Court registrar without a court sitting (unless you request to be heard by a judge in a court sitting).

If at any stage your application is considered to not be 'simple and uncontested' a registrar can refer it to a judge to be heard.

What is a 'simple and uncontested' application?

'Simple' succession applications have no complicating factors. Examples of what could be considered 'simple' succession includes:

- all the people to succeed are the natural children of the person who has passed away, and they will all receive equal shares in the interests; or
- further land interests or shares owned by a person who has passed away are identified and can be succeeded to by the same people in the same way as the earlier interests.

Your application will be considered 'uncontested' when:

- it has been notified according to Māori Land Court Rules; and
- it has been published in the Māori Land Court's National Pānuī; and
- no one has objected to the application.

Why make this change?

The time and travel costs associated with attending a court sitting are removed when an application can be decided by a registrar.

This approach also supports the efficient running of the Māori Land Court.

What do I need to do?

The process for applying for succession has not changed. Apply by completing the appropriate application form. Forms are available at Māori Land Court offices or on our website.

If you prefer your application is decided in court by a judge, tick that option on the application form.

It is important to include all relevant information for your application to be assessed as 'simple', so complete the application form carefully and completely.

You also need to notify any party named in the application and any person affected by the application.

When we roll out our new technology system, you will be able to make this application online via the Māori Land Court website. Check our website to see whether online applications are available at the time you make your application.

Can a registrar's decision be reviewed?

Yes, if you are affected by the decision you can apply for a review of a registrar's decision within 20 working days of the decision being made (or longer if you have a good reason).

The review will be done by a judge, who will be able to confirm, change or cancel the decision and issue a court order.
