## Applications for Determination by a Registrar Which are Considered Simple and Uncontested

The following applications have been lodged, under sections 113A or 235A of Te Ture Whenua Māori Act 1993, for determination by a Registrar which are considered simple and uncontested and can be dealt with without a formal hearing.

If you are interested in, or affected by, one of these applications and wish to make submissions or provide evidence concerning the application, you must notify the Registrar in writing by 4 pm on the 3rd January 2022, providing your name and address, telephone number, and email address (if any), and setting out your connection to the application and brief details of your concerns.

The Registrar may, on receiving your notification, arrange for the application to be set down for a formal hearing before a judge.

Where a determination or order has already been made by a Registrar, affected persons may also apply to the court to seek a review of that determination or order. A review must be lodged within 20 working days after the determination or order is made or, at the satisfaction of a Judge, within a longer period.
