The Registrar may, on receiving your notification, arrange for the application to be set down for a formal hearing before a judge.

Where a determination or order has already been made by a Registrar, affected persons may also apply to the court to seek a review of that determination or order. A review must be lodged within 20 working days after the determination or order is made or, at the satisfaction of a Judge, within a longer period.

Under rule 5.11(1) of the Māori Land Court Rules 2011 the Registrar of each Court in each District must prepare a quarterly schedule of applications on the last day of February, May, August and November listed the applications that were filed with the Court 6 months or more before the date of the schedule and that have not been finally determined. In accordance with rule 5.11(2)(b) of the Māori Land Court Rules 2011, the next list of outstanding applications is available on the website at <https://maorilandcourt.govt.nz/about-mlc/publications/national-panui/>

Note: Rules 3.18 and 5.3(1) of the Māori Land Court Rules 2011 provide that an application lodged in the office of the Chief Registrar must be notified in the next available pānui and in all pānui following until the application is disposed of or notified for hearing or for inquiry and report.
