## COVID-19 Response Act: guidance for Māori entities

The *COVID-19 Response (Requirements for Entities – Modifications and Exemptions) Act 2020* provides temporary relief for governance entities who are unable to meet their statutory obligations or the obligations in their constitution or rules because of the COVID-19 outbreak.

The Act covers many entities such as Māori land trusts established under Te Ture Whenua Māori Act 1993.

It will help entities affected by the COVID-19 restrictions to operate more effectively, by allowing for:

- an entity to use electronic means (e.g. electronic voting and electronic signatures) when its constitution or rules do not permit this;
- an entity to temporarily modify its constitution or rules;
- the Minister for Māori Development to grant exemptions from certain statutory obligations under Te Ture Whenua Māori Act; and
- the Chief Judge of the Māori Land Court to grant relief from certain terms of Māori trust orders and Māori incorporation orders.

The Act covers the period 21 March to 30 November 2020.

We have produced guidance on the Act for:

- Māori land trusts;
- Māori incorporations;
- body corporates or trustees appointed to administer a Māori reservation; and
- assembled owners (under Part 9 of Te Ture Whenua Māori Act).
