Māori Land Court Quarterly Schedule of Outstanding Applications Rule 5.11(1) Māori Land Court Rules 2011

Under rule 5.11(1) of the Māori Land Court Rules 2011 the Registrar of each Court in each District must prepare a quarterly schedule of applications on the last day of February, May, August and November listed the applications that were filed with the Court 6 months or more before the date of the schedule and that have not been finally determined.
